ELIGIBILITY/ARTIST: Nevada Watercolor Society (NVWS) Signature Show is open to Signature Members only.

ELIGIBILITY/ORIGINALITY: Artwork must be original in composition/design and not copies of other artist's work, including photographs by persons other than the artist unless permission has been obtained. Artwork must have been completed in the last two years and exhibited in no more than one prior NVWS show (if artwork has been in previous shows and won an award, it will be ineligible to receive an award in this show).

ELIGIBILITY/MEDIUM: Paintings must be completed with 'water media' on surfaces specifically designed to accommodate 'water media' as defined, and must be painted in a primarily aqueous manner. 'Water media' means watercolor, acrylic, water soluble ink, gouache, casein, egg tempera, watercolor pencil, and watercolor crayon. Collage is acceptable if all collage elements are water media and painted by the artist. Pre-printed papers and mats, digital art, and reproductions are not allowed.

NON-REFUNDABLE ENTRY FEE: Entry is limited to 3 pieces per artist. An entry fee of \$20.00 for the first painting and \$15.00 each for each additional entry. Diptychs and triptychs are considered two & three paintings respectively. Fees may be paid online via PayPal (credit card statement will appear as NEVADA WATER) or by mailing a check to address indicated below.

JPEG IMAGE SPECIFICATIONS:

- Color must be accurate for juror review & publication
- Minimum of 1200 pixels on the longest side
- Size not to exceed: 3 MB
- Images must be cropped to exclude frames & mats
- Correctly oriented (vertical or horizontal)
- Each image must be labeled in the following manner:
 - Show's Shorthand: "21sig_"
 - Artist's Identifier: first 4 letters of artist's last name followed by the first initial
 - Entry number: (01, 02, 03)Ex: 20sig_SmitJ01.jpg (1st entry by John Smith)
- Images are to be emailed to nvws.artshows@gmail.com by entry deadline

ARTIST BIO: Provide a biography of yourself in the 3rd person that explains who you are, how long have you been creating, and what inspires you to create. (~200 words or less). This may be used within the catalog and on Instagram posts.

ENTRY FORM: Complete entry form online at nevadawatercolorsociety.org or mail your entry form to address indicated below. All forms must be received by deadline.

ACCEPTANCE/REJECTION: All entrants will be notified by date listed. All decisions by Juror & Show Chairperson are final.

AWARDS: The Juror of Awards will make selections based on digital images. Cash awards are dependent on the number of entries received. Merchandise awards are dependent on donations of sponsors.

SALES: Paintings may be priced for sale or not for sale (NFS). NVWS does not take a commission from sales of paintings nor handle negotiation of sales. Buyer is placed in contact with artist.

ARTIST'S AGREEMENT: Submission of the entry shall serve as an agreement by the artist that all conditions in this prospectus have been met. Artist agrees to allow use of accepted work for show promotion, including but not limited to: website, Instagram, emails, and promotional flyers. Artist may be disqualified from exhibit for failure to submit entry form, payment, and digital image by the deadline.
